Social Emotional Learning

CABE Model policy 6142.101

Discussion included review of social emotional curriculum standards from pre-k to twelve.

Curriculum throughout the district is age appropriate. Portland High School is seeking a more robust curriculum and will be participating in a research study for "Ruler for High School Students."

The policy committee will not be recommending formal policy for Social Emotional Learning at this time.

Title IX Policy Revised Policy and Regulations 4000.1, 4200.1 and 5114.55
Cabe Policy Highlights dated January 16, 2025, details the court order to set aside the TITLE IX Final Rule 2024 and to return to the previous policy dated 2020.
Discussion took place about the forms, changes, the process for investigation of any violations detailed under TITLE IX and the retraining of our Pupil Services Administrator.

These policies TITLE IX 2020 (4100.1, 4200.1, 5114.44) will be brought to the full board to review, waive a first reading and approve to be compliant. Legal references will include the following court ruling from the U.S. District Court for the Eastern District of Kentucky overturned the 2024 Title IX regulations on January 9, 2025.
